INFORMATION LITERACY NEEDS IN REMOTE AREAS (CASE STUDY ON THE ISLAND OF ACEH)

Abstract

The purpose of this research is to know the needs of information literacy in remote areas of Aceh Island. The method in this study is a aualitative research method with a direct approach to the source of research informant namely Pulo Aceh community, long time this research was conducted for four months in Pulo Aceh. The result of this research is that the people of Pulo Aceh should get the same rights in fulfilling the needs of information, they also have the same needs of information literacy as other communities. Therefore, libraries need to pay attention to areas that are left behind in the dissemination of information. The library as an information center should have an effort to reach isolated areas such as Pulo Aceh. Libraries must provide service information regardless of ethnic. racial, geographic location, and other backgrounds. The role of the library in fulfilling the information needs to Pulo Aceh community is more noted and prioritized as an isolated area. With the fulfillment of information needs they are able to develop competitive with other communities to improve information literacy, but more advanced technological development in order to provide comprehensive information services to remote areas. So they can get information quickly, and relevant and adapted to the needs of the community Pulo Aceh.

Introduction

Globalization of information very rapidly in the information age today have such a huge impact on either side of the positive or negative for the seekers of information. Impact plus was the opening of various kinds of information so that information seekers have the opportunity to get the information widely. One alternative in meeting the needs of information literacy is by way of the library should utilize line ship to reach remote areas of Pulo Aceh. But this is not an effective alternative in meeting the needs of the literacy needs of information on Pulo Aceh, caused by obstacles for librarians in the adjust the State of the sea. But remote areas became the longest move, in the absence of information by spread to remote areas of the community, this was not in accordance with the principle of Rangganatan opinions. Therefore, the Pulo Aceh region is one of the remote isolation in getting maximum information.

The library is expected to improve its information services actively. One of the appropriate measures to tackle it is to ways to further expand the dissemination of information to remote areas such as Pulo Aceh, to be able to meet the need for information, so that the Pulo Aceh is able to membenah myself to moving fast in adjusting both in terms of knowledge and development, UN regions.

The author's observations in the field, it still shows that the existence of the complaints against the fulfillment of the requirement for information on Pulo Aceh. They are always lagging behind both in terms of education, and the development of the region. In this case the author argues library must manifest their desire to improve the aspect of education and development, UN terrain in a way help them get other sources of information more relevant and Up to date.

The idea of the author in response to fulfilling the information needs of remote areas in Pulo Aceh, libraries need to be fair in giving information to all walks of life. Hence from that good contributions in realizing fair attitude to maximize the dissemination of information in remote areas make it a top priority in meeting the needs of information literacy.

Prasetyawan paint the views, on 10 January 1989, The Presidential Commite on Information Literacy published a report which in essence emphasizes the importance of information literacy and information literacy to develop opportunities in the the school. The Commission recommends the establishment of the National Forum on Information Literacy, a coalition of 90 national and international organizations. - 3. Evaluate information and its sources critically
- 4. Combine the information chosen to be a foundation of knowledge
- 5. Use the information effectively to accomplish a specific goal
- 6. Knowing the issues of economic, legal, and social surrounding the use of information

The challenges of information society literacy is a contribution in support of the achievement of the Government's

The Importance of Information Literacy

Mishra Pattah posited in the development of information technology has brought about drastic changes in procurement,

organization, management and dissemination of information.¹³ However, according to Walker and Jones Pattah, technological advances in communication and information is not necessarily ease the process of re-discovery of information, it may even be difficult for search. On the other hand, the development of technology is closely related to a change in attitude or behavior and abilities of users in finding information and using the information that it needs. For some end-users interact directly with information systems is complicated.

The author argues that, hope is able to sense the development of information technology for the remote community be a very difficult thing for them. This fact is evident from the circumstances of those who are still lags behind both in terms of obtaining information as well as in terms of the services of the Government. The growing technological development can not improve literacy information for remote people in Pulo Aceh. Whereas the community is in need of information literacy in order to follow the development of the times.

According to Mishra in Pattah, this happens due to the increased amount of information as well as the quality of information that is not obvious to the user. In addition the information received in a variety of media (multimedia) including images, or text. People also began to question the
